Primary Election**

May 12, 2026,

Because the law requires rotation of the candidate names, the order of appearance as listed may be different in your precinct and because some candidates are nominated by specific districts, names listed in this sample ballot may not appear on the ballot in your precinct. Those offices that did not receive the required number of candidate filings will not appear on the Primary Ballot but will automatically be forwarded to the General Election on November 3, 2026. (NE Statute R.R.S.32-803)

INSTRUCTIONS TO VOTER

1. TO VOTE, YOU MUST DARKEN THE OVAL COMPLETELY (●).
2. Use a black ink pen to mark the ballot.
3. To vote for a WRITE-IN candidate, write in the name on the line provided AND darken the oval completely.
4. DO NOT CROSS OUT OR ERASE. If you make a mistake, ask for a new ballot.
